Among the renowned scholarly series dealing with this subject, the *Beiträge zur historischen Theologie* holds a special position. For more than 80 years, this series has been providing a forum for the publication of outstanding historical-theological monographs only whose design and appearance correspond to the high quality of the content. This series does not accept collections of essays or conference volumes. The series focuses on studies of all periods of the history of the church and theology. In addition, it also publishes the best historical studies which deal with subjects pertaining to exegetical, systematic and practical-theological disciplines.

The first eleven volumes of the series, supervised directly by the publisher Oskar Siebeck himself, were published between 1929 (E. Lohmeyer: Grundlagen paulinischer Theologie) and 1936 (E. Hirsch: Studien zum vierten Evangelium). After the Second World War, the series was reestablished with Gerhard Ebeling as its editor. After 28 years and the publication of 45 volumes (*BHTh* 12, 1950 to 57, 1978), the editorial responsibility was passed on to Johannes Wallmann (*BHTh* 58, 1979 to 119, 2002) for a quarter of a century. The volumes which have been published since, and those which will be published in the future, have all been and will continue to be bound by the strict, time-honored tradition of the series.

This did not change until the radical transformations of Christianity during the Age of Enlightenment. It was German Protestant scholars of the 18th century in particular who shed light on the proceedings and the outcome of the Pelagian controversy and objected to the traditional assessment. In doing so, they altered the view on Pelagius, Augustine and their theology.

As the originator of the term »Germanisation of Christianity«, the Protestant theologian and writer Arthur Bonus (1864–1941) is often counted as having been a pioneering German theologian between the time of the Empire and the Weimar Republic. Christopher König's study is the first to draw together the widely-scattered work of Bonus and place it in the context of the controversies surrounding the reform of the church, society, nation, and worldview that took place in the intellectual environment of cultural Protestantism around 1900. With the demand for a »German faith« that was as polarising as it was suggestive, Bonus rebelled against the foundations of protestant theology and the church, declaring war on historicism and liberal thought.

Paul Silas Peterson presents Karl Barth (1886–1968) in his sociopolitical, cultural, ecclesial and theological contexts from 1905 to 1935. The time period begins in 1905, as Barth began to prepare for a speech on the »social question« (which he held in 1906). It ends in 1935, the year he returned to Switzerland from Germany. In the foreground of Peterson's inquiry is Barth's relation to the features of his time, especially radical socialist ideology, WWI, an intellectual trend that would later be called the Conservative Revolution, the German Christians, the Young Reformation Movement, and National Socialism. Barth's view of and interaction with the Jews is also analyzed along with other issues, such as radical thinking, anti-liberalism, alterity, anti- or trans-historicism, Expressionism, and New Objectivity. The author also addresses specific questions disputed in the secondary literature, such as Barth's theological development, the place of WWI in his intellectual development, his role in the Dehn Case, his reaction to the rise of fascism in Europe, his relationship to 19th century modern liberal Protestantism, his relationship to the Leonhard Ragaz-wing of the Religious Socialists, and his relationship to the Weimar Republic.

Jan Löhdefink looks into how perception of the devil changed during the early days of the Reformation and how this affected time consciousness. He describes the reformatory remodulation of interpreting the past, understanding the present and future prospects, which because of their strongly polemical contrasts with conflicting concepts reveal their own constitution-requirements of time perception and indicate a fundamental shift of the understanding of time. Perceptions of the devil are generally attributed to the backward-looking aspects of the Reformation. However, with an eye on the inherent new configurations of the contemporary temporal structures specific to reformatory devil-perceptions, the results are reversed: as unmodern as the devil may appear to the Modern Age, he has a key position in its origins.

And although at first glance this also seems to be the case in Ebeling's work, Ruth Görnandt shows that by reconnecting his critique of metaphysics to its contemporary and historical background, it is revealed that it is not only rooted in a specific vein of German protestant theology – namely that of Albrecht Ritschl, Wilhelm Herrmann and Rudolf Bultmann – but rather is also a response to the questioning of theology's modern day validity. Daniel Schenkel was one of the most influential Protestant theologians and church politicians in the mid-19th century. During his theological career he developed from a student of de Wette into a pietist before finally becoming one of the leading representatives of theological liberalism during the conflict on church union in Baden. Dorothea Noordveld-Lorenz examines Schenkel's theological thought and his actions as a church politician. Schenkel's theory of Protestantism focused on a specific interpretation of conscience: Schenkel saw man's conscience as the place in which an immediate relationship with God is realized in a way that God is actually present in man's conscience. The essence of Protestantism is to restore and preserve this immediate and non-substitutable relationship between God and a person. Thus Schenkel understood Protestantism as the religion of freedom and as such as the spiritual foundation of a free and modern society.

He was also the first one to have a falling out with him. Thus Karlstadt's significance for the Reformation has always been regarded somewhat ambivalently. Although some saw him as the prototypical betrayer of Reformation unity, for others he became a role model for reformed, congregational or Anabaptist elements in the early Wittenberg Reformation. Martin Keßler emphasizes the exigency of a fundamental revision of Karlstadt's image. He portrays the significant studies written on Karlstadt since the 17th century and examines the major developments in historical and theological research in the 19th and 20th centuries.
