In this volume the person and activity of Jesus is presented from the perspective of different theological disciplines. The background of Jesus' activity in Old Testament writings is considered as is the relationship of his earthly career and the emergence of Christian faith. Developments in church history, caused by the earliest accounts of Jesus' life and teaching, are outlined. From a systematic viewpoint the new relationship to God, effected by Jesus Christ, is reflected on. The contribution from practical theology looks at forms of adaption of Jesus' person and teaching in ecclesiastical and social contexts. Finally, the role of Jesus in other religions is considered. Thus the volume presents the person of Jesus Christ as the centre of Christian faith according to the current status of research and does so in a manner which makes him accessible also for those not accustomed to theological terminology and discourse.

In addition, the concept of creation has also been applied in contexts apart from theology and the church. The frequent designation of the world as a creation in the sense of an environment which is to be preserved is usually too narrow a view and does not provide a sufficient interpretation of the various meanings of the theological discourse on creation. Conversely, the theological use of the term »creation« often suffers from a premature dismissal of its specific relation to the world. The articles in this volume show how creation can be seen in a theologically appropriate manner and at the same time in a form communicable to the public from the perspective of individual theological disciplines but also in its entirety.

The Lord's Supper (or the Eucharist) was from the very beginning a pivotal distinguishing feature of Christianity. This volume deals with its historical origins, the importance attached to it, the controversies involved as well as the variety of present forms of the Lord's Supper. In addition, it provides an answer from the perspective of Protestant theology to the question of how the presence of Christ can be seen today in the Lord's Supper. The relationship to the communal meals in Israel (for example the feast of the Passover) and other ceremonial meals in antiquity completes the pictures from the perspective of religious and cultural studies. Thus the authors provide a comprehensive impression of the current research on the Lord's Supper inside and outside of theology in a readily comprehensible form and give a great deal of information for those wishing to deal in more detail with this subject.
